MEMBERSHIP APPLICATION TERMS AND CONDITIONS

Membership Categories and Entry Requirements

- A) Ordinary Membership
 - a. Malaysian citizens or permanent residents;
 - b. Registered members of the Association;
 - c. Possess a Bachelor Degree in Traditional Chinese Medicine from a university which is recognized by the Association.

B) Life Membership

- a. Ordinary member of the Association who pay life membership fee.
- C) Affiliate membership (fully authorized by the executive of the council.
 - a. Overseas membership
 - i. Possess Bachelor Degree in Traditional Chinese Medicine from a recognized university and also having at least 5 years of clinical practice experience in the previous country.
 - b. Traditional Medicine Practitioner Membership:
 - i. Graduates of the government recognized Traditional Chinese Medicine courses;
 - ii. The practitioner in Traditional Chinese Medicine field for at least 10 years in Malaysia, with supporting documents, and approval by Council.
 - c. Student Membership
 - i. Students who study Traditional Chinese Medicine course in recognized universities/institutions and must present student card for membership application.
 - d. Certificate Membership
 - i. Possess Traditional Chinese Medicine certificate from recognized universities or institutions.
 - e. TCM Industry Personnel Membership
 - i. Shop, Enterprise, Chinese Medicine Herbalist and Herbal Dispenser that are recognized by the Council.
 - f. Sijil Kemahiran Malaysia Membership (Technical and Vocational certificate)
 - i. Possess Technical and Vocational certificate recognized by the government and Council.

Membership applicants must submit the following documents:

- 1. Completed application form.
- 2. Undergraduate certificate, completion letter and transcript. (Chinese format as priority, English format is accepted as alternative if there is no Chinese format.)
- 3. Others supporting documents.
- 4. IC photocopy.
- 5. One (1) passport size photo.

All documents submitted must be certified either by a state assembly representative, *ketua kampung*, Commissioner of Oaths, or ordinary membership holder or life membership holder of the Association, etc.

***If a document is verified by the member of the Association, the certifier's full name, IC number, date, signature and word "CERTIFIED TRUE COPY" must be written, and then submitted to the secretariat office of the Association.

Every applicant, whose application has been approved as aforesaid, shall upon payment of the prescribed entrance fees and first annual subscription, be admitted as a member of the Association and be eligible to all the respective privileges of membership.

Undergraduate university or college students who wish to apply for membership are required to submit documents 1, 4 and 5, with their student identity cards attached. Drop out students shall cease to be a member automatically. Membership applicants are required to submit photocopies of their respective

qualification certificates and supporting documents which are verified by the university or college to the administrative department of the Association for verification in order to become the members.

Members shall pay annual subscription within 30 days of the first month of every year. Payment shall be made to the branch treasurer or to the Association's treasurer where no branches are available.

Application of "Sijil Keanggotaan Perubatan Tradisional Cina":

- 1. Member who interested to apply for of "Sijil Keanggotaan Perubatan Tradisional Cina" is required tosubmit certified true copy of relevant practicing documents (if any).
- 2. Applicant is required to pay RM100.00 for first time application; and RM50.00 every year for renewal.

Application Procedure:

Applicants shall complete the membership application form duly and submit to the administration office for verification. Thereafter the applications will be submitted to the Council within a month for the inspectors to check. After checking, qualified applications will be submitted to the president for approval.

Special subscriptions or levies:

Special subscriptions or levies for particular purposes may be imposed on members after the resolution by Central General Meeting of the Association. If any member fails to pay such subscription within a designated period, the amount due shall be added into the annual subscription to be paid in the following year.

MEMBERS' PRIVILEGES

- 1. Only ordinary members, life members and overseas members are permitted to use the title of "Yi Shi" meaning the doctor of Traditional Chinese Medicine.
- 2. Only citizens and permanent residents of Malaysia are eligible to be ordinary members or life members.
- 3. Only ordinary members and life members are eligible to vote and to be voted in the Central General Meeting.
- 4. All members are permitted to voice their opinions and vote for decision in general meeting.
- 5. The Association is obliged to send notice in writing to all members of its meetings and activities. All members have the rights to participate in the activities organized orco-organized by the Association with terms and conditions.
- 6. Only ordinary members who have joined for 2 years and above are qualified to be Council members.
- 7. All affiliate members are conferred the same privileges as ordinary members except the right of voting in Council election and to be voted as a Council member.

MEMBERS' OBLIGATIONS:

- 1. Abide by the nation's law.
- 2. Abide by the Constitution
- 3. Abide by the code of practice and ethics.
- 4. Abide by the resolutions approved by the Central General Meeting.
- 5. Participate actively in the academic or skills training activity/courses organized by the Association or any other recognized professional bodies.
- 6. Attend the annual Central General Meeting.

TERMINATION OF MEMBERSHIP

- 1. Termination of membership shall be effective by notice in writing addressed to the administrative department of the department, be it the branch or headquarter.
- 2. Members who allow their arrears to exceed 6 months will receive a written notification by the administrative department. Members whose arrears exceed one year shall render their membership be upon notification in writing be automatically terminated.
- 3. Members who wish to reinstate membership are required to settle the arrears and write in to explain the reasons of arrears. The reinstatement is subject to the decision by the Council members.
- 4. Members who violate the ethics of the Association shall be subject to disciplinary proceedings of the Ethics Committee, whose report shall be submitted to the Council to act on its findings and decide on the termination of membership.
